



## CASCADE MICROTECH, INC. IS CHANGING ITS NAME TO FORMFACTOR BEAVERTON, INC.

### THE NAME IS CHANGING, BUT NOT OUR DEDICATION TO CUSTOMERS

In 2016, FormFactor, Inc., acquired Cascade Microtech, Inc., which became one of FormFactor's wholly-owned subsidiaries. This combination strengthened the position of FormFactor in the semiconductor test and measurement market through increased scale and diversification to better serve our customers.

As part of uniting our corporate identities, Cascade Microtech, Inc. will be changing its name to **FormFactor Beaverton, Inc.**, effective **May 14, 2018**.

We appreciate your actions to accommodate this change. Please read this notice carefully.

- **Before** May 14, 2018, please make sure that your organization can issue purchase orders and pay invoices to "FormFactor Beaverton, Inc." (see below)
  - Other than the change of name, the information associated with Cascade Microtech, Inc. will be the same.
  - Please continue to issue purchase orders to Cascade Microtech, Inc., until May 14, 2018.
- **Starting** May 14, 2018, please issue all purchase orders using the "FormFactor Beaverton, Inc." name and account information, in place of "Cascade Microtech, Inc." for all applicable products.

## General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

### Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

- Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)
